On the listed date and time, S-2 stated that S-1 came into the location and stabbed him with a knife. S-2 also stated he blanked out during the assault.

W-1 states that S-2 had a verbal altercation with S-1 on 8-2-18, advising him to leave the location, due to his drug use in front of the building. W-1 also stated S-1 came back to the location on today's date and stabbed S-2, which led to S-2 retrieving the knife and stabbing S-1. S-1 is not a resident at the location.

W-2 stated that S-1 came into the location and stabbed S-2 and S-2 then stabbed S-1 with the same knife.

S-1 did not give a statement.

S-1 and S-2 sustained several injuries and were transported to the Howard Hospital and later admitted, due to their injuries.
