A RADIO ASSIGNMENT WAS RECEIVED FOR 2700 MARTIN LUTHER KING JR. AVENUE S.E. FOR A STABBING. UPON ARRIVAL V-1 WAS BEING TRANSPORTED TO MEDSTAR WASHINGTON HOSPITAL CENTER BY DCFD AMBULANCE 25. THE UNDERSIGNED OFFICER SECURED AN OUTSIDE CRIME SCENE NOTIFYING A 7D DETECTIVE AND DFS. A PRELIMINARY INVESTIGATION REVEALED THAT V-1 AND D-1 WERE IN THE RESTROOM WHEN AN ARGUMENT ENSUED IN REFERENCE TO AN ASSAULT THAT OCCURRED PRIOR. S-1 BEGAN STABBING V-1 WITH A POCKET SIZE KNIFE. V-1 FEARING FOR HIS LIFE RAN FROM THE BATHROOM INTO THE DAY ROOM AND THEN TO THE OUTSIDE WHERE HE COLLAPSED UNTIL THE ARRIVAL OF DCFD. C-1 AND OTHER SPECIAL POLICE OFFICERS CHASED AND DETAINED S-1 UNTIL THE ARRIVAL OF OFFICERS. DETECTIVES HAVE VIEWED CAMERA FOOTAGE OBTAINED BY CAMERAS AT THE LOCATION. OFFICER P. VAILLANCOURT# 2234 BODY WORN CAMERA CAPTURED FOOTAGE FROM THE SCENE AS WELL. INVESTIGATOR HARRELL OF THE 7TH DISTRICT OFFICE IS INVESTIGATING 7D30.
